ORDER

No. HOME-OSS-APMT1-0001-2024 37778 /OSS, dated 14th October, 2024

Odisha Public Service Commission vide their Memo No.9553/PSC Dt.30.12.2023 and Memo No.500 Dt.25.01.2024 had recommended 787 candidates pursuant to the Advertisement No. 26 of 2021-22, for their appointment in the post of Assistant Section Officer in Odisha Secretariat (Group-B). Out of the list of 787 candidates, appointment orders were issued in favour of 716 candidates and 71 candidates were not been considered for appointment to the post of ASO for different reasons vide this Department Notice No.5703 Dt.12.02.2024.

After careful consideration of the request of one selected candidate namely Sri Tariprasad Das out of the above 71 candidates and in pursuance of Odisha Secretariat Service (Method of Recruitment and Conditions of Service) Rules, 2016 and amendment thereto, the State Government do hereby appoint Sri Das, as detail below, in the post of Assistant Section Officer in Odisha Secretariat Service (Group-B), in Cell-01, Level-09 (Rs. 35,400/- to 112400/-) of the Pay matrix under Odisha Revised Scale of Pay Rules, 2017 with usual D.A & other allowances as admissible to Government employees from time to time, from the date of his actual joining in the post. The appointment is subject to final outcome of SLP (C) No. 1302 of 2024 pending before the Hon'ble Supreme Court of India.

On being appointed as Assistant Section Officer, he is hereby posted to **Home Department**.

He shall remain on probation for a period of two years from the date of joining in the service subject to fulfillment of the following conditions.

1. The appointment is purely temporary and can be terminated at any time without assigning any reason thereof.
2. He is instructed to join in the Department within 30 days from the date of issue of this appointment order failing which the appointment shall be automatically cancelled.

He is instructed to furnish the following documents to the Department at the time of his joining.

- Two Character Certificates issued by two different Gazetted Officers(Original)

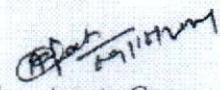

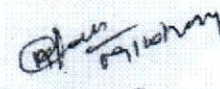

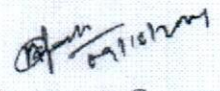
