NOTIFICATION

Whereas it is felt necessary to extend the tenure of the Commission of Inquiry consisting of Hon'ble Shri Justice Chitta Ranjan Dash (Retd.) appointed vide this Department Notification No. 1301/C, dated 22.09.2024 to enquire into cases and counter cases lodged alleging misbehavior / assault of a woman and a serving army officer inside Bharatpur PS, Bhubaneswar;

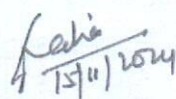
