13	06.12.2024	A petition has been filed, (which the Office is directed to register as Misc. Petition no. 4 of 2024) at the behest of Miss 'X' and Mr. 'Y' seeking copy of the following documents: a. Station Diary book of Bharatpur Police Station from 13.09.2024 to 16.09.2024, b. Video Recorded in the Phone of Capt. Gurvansh Singh Gosal on 15.09.2024 which is seized by the Investigating Agency, c. Copy of the FIR of CID CB Case no. 10 of 2024, CID CB Case No. 11 of 2024 and CID CB Case No. 12 of 2024, d. Copy of the Seizure List in all the three FIRs.	

	2. The I.O. of the CID (CB), Mr. Narendra Kumar Behera, is present. He submits that the video recordings seized during investigation have not yet been received from the State Forensic Laboratory along with the report. He further submits that latest by 10th or 11th of December, 2024, he expects to receive the aforesaid material objects along with the reports. 3. It is unanimously agreed by Mr. Yasobant Das, learned Sr. Advocate and Mr. Soura Chandra Mohapatra, learned Sr. Advocate that without the aforesaid materials, it is difficult to proceed for cross examination. 4. Taking into consideration the submissions made, the prayer in the petition is allowed. The copies of the aforesaid records, except the video

	recorded in the phone of Capt. Gurvansh Singh Gosal on 15.09.2024, be supplied to the learned Counsels for the parties immediately after those are received. 5. So far as the item at Serial No. (b) is concerned, the same shall be played by the I.O. in presence of the learned Counsel for the parties and the parties before the cross examination is taken up, if pressed by any of the Counsels. 6. It is unanimously submitted by Mr. Yasobant Das, learned Sr. Advocate appearing for Miss 'X' and Mr "Y" and Mr. Soura Chandra Mohapatra, learned Sr. Advocate appearing for the police personnel that they have no preliminary objection regarding the public notice and service of notice etc. on their clients. Mr. Jena, learned Counsel

So far as the procedures settled by the Commission in order dated 26.11.2024 is concerned, there is also no objection by any of the Counsels. It is submitted by them that at the relevant time they may suggest any effective procedure, if necessity of the same is felt in course of the proceeding. 8. In view of non-receipt of the police records in CID (CB) Case nos. 10,11 & 12 of 2024, especially, the material objects i.e. the video records, it is difficult to proceed in the matter. The case is, therefore, fixed to 18.12.2024 awaiting receipt of the police papers and the relevant material objects. Learned Counsels for the parties
