Office is directed to prepare three sets of copies of the said documents to supply to learned counsels for Miss 'X' and Mr 'Y', learned counsels for the police personnel and learned counsel for the alleged road razors in course of the day.	

		5. Heard learned counsels for the parties. 6. Learned Counsels appearing for the police personnel have filed a petition for supply of video clips, as detailed in the paragraph-2 of the petition. The petition be numbered as Misc. Petition No.5 of 2024. List of witnesses supplied by the learned counsel for police personnel is submitted before the Commission. They want to cross examine all the 7 witnesses, whose affidavits were supplied to them in compliance to Section 8(B) of the Act. 7. Learned counsel for Miss 'X' and Mr 'Y' is directed to file the list of witnesses on 21.12.2024. 8. On perusal of the petition, it is submitted by the I.Os that the video recording made by S.I. Baisalini Panda and A.S.I. Sagarika Ratha having been seized during investigation, had been sent to the State Forensic Science Laboratory for testing their authenticity. The report in respect of the clips have already been received by them.

The video clips as detailed in the para-2 of the petition being electronic evidence, shall not be supplied to the parties, but the same shall be played in the Court Room for viewing by the parties and their counsels on the basis of which they may cross examine the witnesses of each side. 10. The I.Os are directed to clone the video records as detailed in the para-2 of the petition in two different pen drives, one in respect of recorded material seized from the mobile phone of S.I. Baisalini Panda and another for the video material seized from the mobile phone of ASI Sagarika Ratha. The sealed packet be produced before this Commission, which shall be opened in presence of learned Counsel for the parties and the I.Os on 21.12.2024 at 11 a.m. 11. Learned Asst. Secretary-cum-Court Officer is directed to clone two copies of the pen drive which are stated to be there in the sealed cover for the purpose of Office record and the original cloned copy

The I.Os are directed to be present on 21.12.2024 with the materials i.e. the Forensic report in respect of the extract from the seized mobile phone of SI Baisalini Panda and ASI Sagarika Ratha. Accordingly, the case is posted to 11 a.m. on 21.12.2024 for further hearing.
