E (Marked by the I.O.) is the video recorded by Mr.Y. 6. Learned Asst. Secretary-cum-Court Officer is directed to clone the video already viewed by the parties and their counsels in presence of the I.O. for reference by the Commission at the time of preparation of report. 7. It is made clear that all the videos are there in the materials

Cross examination of Miss X is taken up by Mr. Soura Chandra Mohapatra, learned Sr. Advocate appearing for the police personnel
