RESOLUTION

Sub.: Realignment of Ministerial Officers of Odisha Police with Executive Ranks: Compliance of clause 2(c) of this Department Resolution No. 36614/D&A dated 16.10.2021.

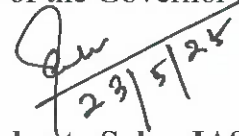
Home Department vide it's Resolution cited apropos had withdrawn the executive ranks which was conferred upon ministerial officers of Odisha Police vide it's earlier Resolution No. 34227/P dated 07.09.1974.

2. Now, in light of orders of Hon'ble Court (a. Order dated 21-11-1998 in OA No. 2609/1994; b. Order dated 20-11-2008 of Hon'ble High Court of Odisha in OJC No. 7467/1999; & c. Order dated 10.07.2009 of Hon'ble Supreme Court in SLP CC 8000/2009) and in order to comply with clause 2 (c) of Resolution cited apropos in toto, it was felt necessary for one time realignment of ministerial officers of Odisha Police with executive ranks, as detailed at Annexure, during the period 20.09.1994 (the date w.e.f. which Inspectors were conferred Gazetted Class-II Status & DSPs were conferred Gazetted Class-I status vide Home Department Resolution No. 49475/SPS dated 20-09-1994) to 05.11.2021 (the date on which Home Department Resolution No. 36614/D&A dated 16-10-2021 came into effect).

3. It is hereby reiterated that Executive Ranks conferred on Ministerial Officers of Odisha Police have already been withdrawn vide Home Department's Resolution No. 36614/D&A dated 16.10.2021 and they are under the ambit of Odisha Civil Services (Classification, Control & Appeal) Rules, 1962 since then.

4. The arrear financial benefits already accrued to the police ministerial officers including retired ministerial officers on the strength of Government Letter No. 29483/SPS, dated the 2nd August 2017 read with Letter No. 8058/SPS, dated the 22nd February 2018 shall be given to them as personal pay, with concurrence of Finance Department after examining the cases on case to case basis as per their entitlement, after realigning the ministerial officers with executive ranks, in accordance with Para-2(c) of Home Department Resolution No. 36614/D&A, dated the 16th October 2021.
