2. The aforementioned newly created posts shall carry usual pay, D.A and other allowances as sanctioned by the Government from time to time.
3. The afore-mentioned regular posts are created with the stipulation that the recruitment shall be made in a transparent manner following the relevant recruitment rules and provisions of ORV Act as amended from time to time.

The promotional posts are to be filled up observing relevant Rules and ORV Act.

4. The aforementioned posts (except the post of Fingerprint Sub-Inspector) shall be encadred in their respective cadres under Forensic Science Service. Hence, shall be entitled to all service benefits as provided in their respective parent cadres.
