RESOLUTION

No. 22821 / PROS, Bhubaneswar, Date 30.05, 2025
PT1-HOME-PROS-PMTN-0001-2023

As per Rule 4.2 of the Odisha State Prosecution Service Rules, 1997, recruitment to the cadre of Additional Public Prosecutor in Group-'A' service shall be made by way of promotion from the cadre of eligible Assistant Public Prosecutors, who have put up not less than eight years of continuous service in that cadre, which will be done in consultation with the Odisha Public Service Commission.

With a view to bring improvement in prosecution system and in order to cater to the needs of public, the State Government, after careful consideration, have decided to appoint more Cadre Addl. Public Prosecutors by giving promotion to the existing Cadre Assistant Public Prosecutors in relaxation of experience criterion.

Now, therefore, in exercise of powers conferred under Rule-22 of the Odisha State Prosecution Service Rules, 1997, the Government after careful consideration and in consultation with Odisha Public Service Commission, have been pleased to relax the required experience criterion to 07 (seven) years in place of 08 (eight) years for consideration of promotion of cadre Assistant Public Prosecutors to the rank of Additional Public Prosecutors in the Odisha State Prosecution Service cadre for the year, 2025.

The relaxation shall be a one-time relaxation and will not form precedence for any purpose in future.
