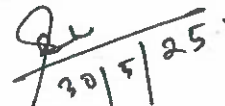
As per Clause (c) of rule 3 of O.C.S. (Criteria for Promotion) Rules, 1992 available CCRs for preceding 5 years are to be taken into consideration for promotion of Cadre Assistant Public Prosecutors to the rank of Additional Public Prosecutors.

With a view to bring improvement in prosecution system, for making the District Directorates fully functional as per the mandate of the New Criminal Laws as directed by ministry of Home Affairs, Government of India and in order to cater to the needs of public, the State Government, after careful consideration, have decided to appoint more Cadre Addl. Public Prosecutors by giving promotion to the existing Cadre Assistant Public Prosecutors in relaxation of PARs/CCRs.

Now, therefore, in exercise of powers conferred under Rule-8 of the Orissa Civil Services (Criteria for Promotion), Amendment Rules, 2009, the Government after careful consideration have been pleased to relax the required PARs/CCRs to 36 (thirty six) months in place of 60 (sixty) months for consideration of promotion of cadre Assistant Public Prosecutors to the rank of Additional Public Prosecutors in the Odisha State Prosecution Service cadre for the year, 2025.

The relaxation shall be a one-time relaxation and will not form precedence for any purpose in future.
