Sub: Enhancement of the rate of Duty allowance/Training allowance of Civil Defence Volunteers of the State.

Sir,

In pursuance of the decision of the Govt. of India communicated in Ministry of Home Affairs, DGCD Letter No.VI-14025/24/2014-DGCD(CD)Part-1-810-931, dated.12.09.2024, I am directed to convey the sanction of Governor for enhancement of the duty allowance and training allowance of Civil Defence Volunteer with effect from 01.05.2025 as detailed below.

Sl. No	Type of allowance	Old Rates	Revised Rates
(a)	Duty allowance-When called out for duty, exercise/rehearsal	Rs.31/- per head per day	Rs. 150/- per head per day
(b)	Parade allowance/Training allowance (when called out for Parade/Training)	Rs.14/- per head per parade/training of 2.5 Hrs duration but not less than 1.5 Hrs Rs.28/- per head per day for more than one parade/training Hrs exceeding 2.5 Hrs duration.	Rs.140/- per head per day for more than one parade/training. Hours exceeding 2.5 Hrs duration (Rs.70/- per head per parade/training of 2.5 Hrs duration but not less than 1.5 Hrs.)

The rates of training allowance/duty call-up allowance to Civil Defence Volunteers fixed in this Department vide Letter No.1785, dt.03.11.1997 is hereby superseded.

The expenditure involved in the payment of the above-mentioned allowance as per revised rate is poolable and shareable between State and Centre as usual as per the existing financial Policy.

This has been concurred in by the Finance Department.
