Whereas Shri Satish Kumar Ishwardas Gajbhiye, IPS submitted an application for deputation to the Centre for an IG level post and the Government of India, MHA, granted approval from the competent authority for the appointment of Shri Gajbhiye S.K. Ishwardas, IPS, as DIG in the Central Reserve Police Force vide appointment order No. I-21017/16/2024-IPS-III dated 6.12.2024;

And whereas the services of Sri Gajbhiye was placed at the disposal of the GoI, MHA, for central deputation, as per the Home Department Notification No. 46887/IPS dated 12.12.2024 and accordingly, the State Police Headquarters relieved Shri Gajbhiye from his duties w.e.f 30.12.2024;

And whereas ,Shri Gajbhiye, subsequently submitted a representation stating that he had not been empanelled for holding IG-level posts at the Centre and, therefore, expressed his disinclination to join the new assignment and his representation was forwarded to the MHA for due consideration vide this Department's letter No. 3296 dated 24.01.2025;

And whereas, Shri Gajbhiye filed O.A. No. 67 of 2025 before the Hon'ble Central Administrative Tribunal (CAT) Cuttack Bench, Cuttack challenging his appointment order issued by MHA dated 6.12.2024 and relieve order of S.P. Hdqrs. dated 30.12.2024;

And whereas Hon'ble Tribunal in their order dated 05.03.2025 did not grant any interim relief, however, made it clear that in case, the applicant reports at Centre, his joining at Centre shall be subject to the final outcome of the OA and the period of his absence from his relieve till joining at the Centre shall be considered as leave due and admissible to him;

And whereas, while the O.A. is still pending, Shri Gajbhiye filed W.P.(C) No.15911 of 2025 before the Hon'ble High Court of Orissa with a prayer to declare the entire action of the opposite parties as illegal and allow the Original Application bearing OA No.67 of 2025 before the Central Administrative Tribunal, Cuttack Bench Cuttack consequentially quashing the impugned orders attached to the Original Application and to direct the opposite parties to grant consequential service and financial benefits;

And whereas, Hon'ble High Court while disposing of the W.P.(C) No.15911 of 2025 filed by Shri Satish Kumar Ishwardas Gajbhiye, IPS (RR-2002) vide order No. 2 dated 13.06.2025 ,directed that in the event the petitioner approaches either the Union of India or the State with a prayer to allow him to join in any of the post befitting to his seniority and status, the same shall be considered by the opposite parties independently in accordance with the applicable rules and circulars holding the field within a period of ten (10) days from the date of such approach without being influenced by any other factors and keeping in view the letter dated 29.03.2025 under Annexure-8 to the writ petition ;

And whereas, in compliance with above orders of Hon'ble High Court, the Shri Satish Kumar Ishwardas Gajbhiye, IPS submitted a representation dtd. 13/6/2025 for acceptance of his joining as IG of Police in the State;

Now, therefore, after careful consideration of the above facts and in compliance to the order of Hon'ble High Court in W.P.(C) No.15911 of 2025, the State Government have been pleased to allow Shri Satish Kumar Ishwardas Gajbhiye, IPS to join in the parent cadre as IG of Police at SPHQr till his further posting is decided following due procedure.
