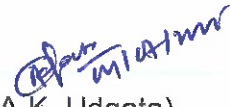

In compliance to Order Dt.02.04.2025 of the Hon'ble High Court, Orissa passed in W.P.(C) No. 6925 of 2024, Sri Ashish Kumar Dash, Establishment Officer, DMET, Odisha, Bhubaneswar under Heads of Department Common Cadre is hereby promoted to the rank of Administrative Officer, in Level-12 of Pay Matrix under ORSP Rules, 2017 notionally with effect from Dt.11.07.2022 i.e. the date of promotion of his immediate junior Sri Jeebanananda Panda to the said rank vide Home Department Notification No.23106 Dt.11.07.2022, on ad-hoc basis for a period of one year or till receipt of recommendation of Odisha Public Service Commission or his retirement, whichever is earlier. On such promotion, Sri Dash is posted as Administrative Officer in the O/o the Director of Health Service, Odisha, Bhubaneswar until further orders.

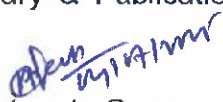
