In exercise of the powers conferred by Section 2 of the Police Act, 1861 (Act No. 5 of 1861), the State Government do hereby make the following order further to amend the Odisha Police Service (Method of Recruitment and Conditions of Service of Assistant Sub Inspectors) Order, 2020, namely: -

1. Short title and commencement.—(1) This orders may be called The Odisha Police Service (Method of Recruitment and Conditions of Service of Assistant Sub Inspectors) Amendment Orders, 2025.

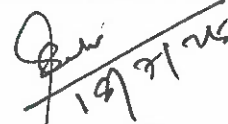
(2) It shall come into force on the date of its publication in the Odisha Gazette.

2. In the Odisha Police Service (Method of Recruitment and Conditions of Service of Assistant Sub Inspectors) Orders, 2020 (here-in-after referred to as the said orders) in order 5, in sub-order (1), in the table, for the words appearing under the subject column against the Serial. No.1, "Law & Rules relating to IPC,1860, Cr.P.C.,1973, The Indian evidence Act,1872, Police Act,1861 and PMR,1940" the following words shall be substituted, namely:-

"Law & Rules relating to Bharatiya Nyaya Sanhita,2023, Bharatiya Nagarik Suraksha Sanhita, 2023 and Bharatiya Sakshya Adhiniyam. 2023, Police Act,1861 , Police Manual Rules, 1940"

3. In the said orders, in order 7, in sub-order (6), for the words " Criminal Procedure Code, 1973 (2 of 1976)" the words " Bharatiya Nagarika Suraksha Sanhita, 2023" shall be substituted.
