The charges of SA & PW Section is withdrawn from Sri Sahoo, Under Secretary to Government, Home Department.

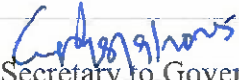

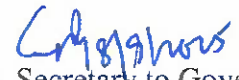
