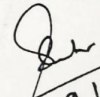
WHEREAS, direction has been received from the Hon'ble Supreme court of India in W.P (Crl.) No.511 of 2024 in D. Kesava Rao @ Dunna Kesava Rao @Azad -vs- State of Odisha & Another for disposing of thirty seven (37) number of cases pending against the D. Kesava Rao @ Dunna Kesava Rao @ Azad;

AND, WHEREAS the Hon'ble High Court of Orissa has also directed for the establishment of a Special Court of Additional District and Session Judge at Paralakhemundi in the District of Gajapati for Speedy trial of cases against D. Kesava Rao as per the order of Hon'ble Supreme Court of India;

AND, WHEREAS it is expedient for the ends of Justice and for the speedy disposal of cases in a time bound manner against D. Kesava Rao;

NOW, THEREFORE in compliance of the order of Hon'ble Supreme Court and High Court of Orissa, the State Government in consultation with the High Court of Orissa and in exercise of the powers conferred by section 3 and sub-section (1) of section 9 read with section 10 of the Odisha civil Courts Act, 1984 (Odisha Act 18 of 1984) and sub-section (1) of section 8 of the Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023 (46 of 2023) do hereby establish a court of Additional District and Session Judge at Paralakhemundi in addition to the existing number of such courts in the judgeship of Gajapati with effect from the date the said court functions with the local limits of jurisdiction in the entire state of Odisha and fix the place of sitting of the said court at Paralakhemundi for speedy trial of cases pending against D.Kesava Rao excluding the cases registered under POCSO Act, 2012 for the time being.

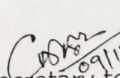
