NOTIFICATION

HOME-DA1-RULE-0013-2021

In exercise of the powers conferred by section 2 of the Police Act, 1861 (Act No. 5 of 1861), the State Government do hereby make the following orders further to amend the Odisha Battalion Service (Method of Recruitment and Conditions of Service of Sepoys or Constables, Havildars and ASI(Armed)) Order, 2022, namely: -

1. **Short title and commencement.**—(1) This order may be called the Odisha Battalion Service (Method of Recruitment and Conditions of Service of Sepoys or Constables, Havildars and ASI(Armed)) Amendment Order, 2025  
  
(2) They shall come into force on the date of their publication in the Odisha Gazette.
2. In the Odisha Battalion Service (Method of Recruitment and Conditions of Service of Sepoys or Constables, Havildars and ASI(Armed)) Order, 2022 (hereinafter referred to as the said order), in order 20, sub-order (B), the following sub-order shall be substituted,-

**“(B) PROMOTION OF HAVILDAR TO ASSISTANT SUB-INSPECTOR OF POLICE (ARMED):-**


- (i) Every year, for the purpose of promotion of Havildar to Assistant Sub-Inspector of Police (Armed), gradation list of Havildars shall be prepared by SAP Headquarters as per their seniority.
- (ii) Havildars completed 5 years of continuous service as such on the 1st day of January of the year in which the Central Selection Board meets shall be eligible for promotion to the rank of Assistant Sub-Inspector of Police (Armed).
- (iii) Constitution of the Central Selection Board ,-  
The Central Selection Board shall be constituted with the following members for selection of eligible Havildars for promotion to the rank of Assistant Sub-Inspector of Police (Armed) as follows namely :-

1	Head of SAP Hdqrs. or Addl. D.G.P., SAP or I.G. of Police, SAP or D.I.G of Police, SAP (To be nominated by the DGP, Odisha)	Chairman
2	Two Commandants of any Battalion (To be selected by the Head of SAP Headquarters)	Member

3. In the said order, in Appendix- A, in clause (6) , for the words “*his entire*” appearing in the second sentence, the words “ *the last 05(five) years of his*” shall be substituted.
