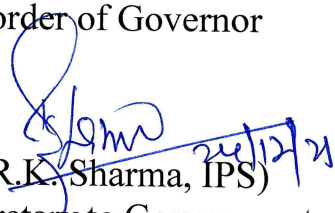
2. Now, after careful consideration, Government has been pleased to revise the same as indicated in the table below.

		c. SOG and AET & RC, Koraput police personnel (including officers) those are not in active operational duty and are deployed for training, administrative and other related matters at Headquarters.	20% of Basic Pay as per ORSP Rules 2017	₹ 12,000 /- per month
2.	Incentive Allowance	District Volunteer Forces (DVF)	30% of Basic Pay as per ORSP Rules 2017	₹ 10,000 /- per month
