ORDER

No. HOME-OSS-CASE4-0001-2025 3547 /OSS, dated 29.01.2026

Whereas on being selected and recommended by the OPSC, Sri Bhupen Kumar Chakraborty has been appointed temporarily in the post of Assistant Section Officer (ASO) and posted in Finance Department vide Home Department Order No. 5116 dated 08.02.2024. Upon submission of the joining report, the joining of Sri Chakraborty, ASO was accepted by the Finance Department with effect from 07.08.2024 (F.N) vide their Office Order No. 22541 dated 08.08.2024. As per the provision of Rule-19(1) of the Odisha Secretariat Service (Method of Recruitment and Conditions of Service) Rules, 2016, the appointment of Sri Chakraborty as ASO is under probation for a period of two years from the date of joining in the service and the appointment is subject to final outcome of SLP(C) No. 1302 of 2024 as well as verification of character and antecedents. As per the terms and conditions of the appointment, it can be terminated at any time without assigning any reason thereof.

Whereas Finance Department reported this Department about the absence of Sri Chakraborty with effect from dated 08.08.2024 without submitting leave application and prior permission of the competent authority. Subsequently, he submitted leave applications in piecemeal manner on different dates and remained absence from duties. Finance Department vide their Letter dated 21.09.2024 and dated 18.11.2024 directed Sri Chakraborty to resume his duties, but he did not respond to it. Subsequently, Finance Department vide their letter dated 25.07.2025 rejected the leave applied by him and directed to join his duty by 04.08.2025, but he did not join. Since his joining, Sri Chakraborty has not performed his duties even for a single day and so far he has not resumed his duties. As such, Sri Chakraborty has violated the instruction of his higher authorities as well as the provisions of Rule-3 and 4 of the Orissa Government Servants' Conduct Rules, 1959.

Whereas Sri Chakraborty was called upon vide Home Department Notice No. 43934, dated 24.10.2025 to submit his explanation within 15 days from the date of issue of the notice as to why his services shall not be terminated under provision of Rule-19(2) of Odisha Secretariat Service (Method of Recruitment and Conditions of Service) Rules, 2016 for willful disobedience of Government order, dereliction in duties and violation of Orissa Government Servants' Conduct Rules, 1959. Sri Chakraborty did not submit his reply within the stipulated time and even after the stipulated time, though the notice was delivered through email on 27.10.2025 and Speed Post on 31.10.2025. As such, it is presumed that he has no explanation to offer.

P.T.O

Hence, in compliance to the provisions under Rule-19(2) of Odisha Secretariat Service (Method of Recruitment and Conditions of Service) Rules, 2016, the service of Sri Bhupen Kumar Chakraborty, Assistant Section Officer is hereby terminated with immediate effect.
