Whereas, Sri Ajay Kumar Padhi, OAPS(S), Ex-Commandant, OSAP 3rd Battalion, Koraput (assigned with Crowd control duty during Car Festival-2025 at Puri) was placed under suspension with immediate effect under Rule 12(1)(a) of the OCS(CC&A) Rules, 1962 pending drawal of disciplinary proceeding against him vide Home Department Order No.27036/SPS dtd. 29/06/2025;

AND whereas, a disciplinary proceeding has been initiated against him vide Home Department Memorandum No.39465/SPS dtd.16/09/2025;

AND whereas, Sri Ajay Kumar Padhi, OAPS(S), Ex-Commandant, OSAP 3rd Battalion, Koraput was re-instated in service pending finalization of the disciplinary proceeding initiated against him vide Home Department Order No.5804/SPS dtd. 13/02/2026 and upon re-instatement he was directed to report at the SAP Headquarters, Odisha, Bhubaneswar for his subsequent posting. Accordingly, Sri Padhi has reported his joining at SAP Headquarters on 17.02.2026 AM.

Now, after careful consideration, Sri Ajay Kumar Padhi, OAPS(S) is posted as Principal TTI, Bhubaneswar.

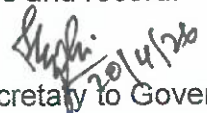
