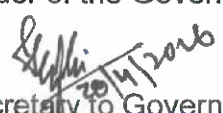
Whereas, Sri Vishnu Prasad Pati, OPS(S), Ex-DCP, Police Commissionerate, Bhubaneswar-Cuttack (assigned with Crowd control duty during Car Festival-2025 at Puri) was placed under suspension with immediate effect under Rule 12(1)(a) of the OCS(CC&A) Rules, 1962 pending drawal of disciplinary proceeding against him vide Home Department Order No.27033/SPS dtd. 29/06/2025;

AND whereas, a disciplinary proceeding has been initiated against him vide Home Department Memorandum No.39462/SPS dtd.16/09/2025;

AND whereas, Sri Vishnu Prasad Pati, OPS(S), Ex-DCP, Police Commissionerate, Bhubaneswar-Cuttack was re-instated in service pending finalization of the disciplinary proceeding initiated against him vide Home Department Order No.5807/SPS dtd. 13/02/2026 and upon re-instatement he was directed to report at the State Police Headquarters for his subsequent posting. Accordingly, Sri Pati has reported his joining at State Police Headquarters, Cuttack on 17.02.2026 AM.;

Now, after careful consideration, Sri Vishnu Prasad Pati, OPS(S) is posted as DCP, Police Commissionerate, Bhubaneswar-Cuttack.

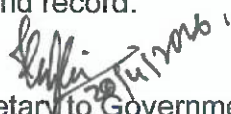

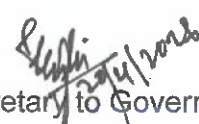
