ORDER

No. PT1-HOME-OSS-APMT1-0005-2024 17607 /OSS, dated 21st May, 2026

Odisha Public Service Commission vide their Letter No.5582/PSC, dated 05.08.2025 and No.4560/PSC, dated 02.07.2025 recommended the names of additional candidates, namely Sri Kumar Debadutta and Sri Debiprasad Kar, pursuant to the Advertisement No. 26 of 2021-22, for their appointment in the post of Assistant Section Officer in Odisha Secretariat (Group-B).

Government, after careful consideration and on relaxation of the provision under Rule, 10(2) of the Odisha Secretariat Service (Method of Recruitment and Conditions of Service) Rules, 2016 vide this Department Notification No.13071 Dt.17.04.2026 approved the revised list of successful candidates, including the additional candidates, furnished by the OPSC vide Letter No. 2083/PSC, dated 08.04.2026. Accordingly, the above candidates are hereby appointed in the post of Assistant Section Officer, in Odisha Secretariat Service (Group-B), in Cell-01, Level-09 (Rs. 35,400/- to 112400/-) of the Pay matrix under Odisha Revised Scale of Pay Rules, 2017 with usual D.A & other allowances as admissible to Government employees from time to time, from the date of their actual joining in the post. The appointment is subject to final outcome of W.P. (C) No. 1990 of 2024 pending before the Hon'ble High Court of Orissa.

On their appointment in the post of Assistant Section Officer, they are posted to the Department as mentioned against each below:

They shall remain on probation for a period of two years from the date of their joining in the service subject to fulfilment of the following conditions.

1. The appointment is purely temporary and subject to verification of character and antecedents and can be terminated at any time without assigning any reason thereof.
2. Upon joining, they will be placed below the candidates already appointed against notified vacancies pursuant to Advt. No. 26 of 2021-22 as per the views of GA & PG Department.
3. They are instructed to join in the respective Department within 30 days from the date of issue of this appointment order failing which the appointment shall be automatically cancelled.

- Certificates in support of Educational Qualification (Original and Photocopy).
- Two Character Certificates issued by two different Gazetted Officers (Original).
- A declaration to the effect that no criminal antecedent/case is pending against them (Original).

- Declaration of non-contact of plural marriage (Original).
- Caste Certificate (If candidate belongs to ST/SC/SEBC) (Original and Photocopy).
- Disability Certificate, if applicable (Original and Photocopy).
- Sports Certificate, if applicable (Identity card of Sports persons issued by the Director of Sports, Odisha) (Original and Photocopy).
- Any other relevant document(s).

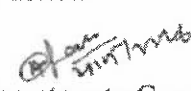

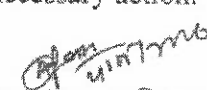
