On being selected for the post of Assistant Section Officer by the Odisha Public Service Commission, Sri Rajendra Majhi was given appointment as ASO vide Home Department Order No. 5446, dated 08.02.2024 and posted to Steel and Mines Department. But, due to pendency of one criminal case against him, Steel and Mines Department did not accept his joining and instructed Sri Majhi vide their Letter No.3763, dated 04.05.2024 to report in Home Department and also forwarded his original joining report dated 13.02.2024 (F.N.) to this Department.

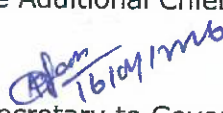
The joining report of Sri Majhi could not be accepted till date due to pendency of the criminal case as well as in view of the orders of Hon'ble High Court passed in W.P. (C) No. 11904 of 2024 (Rajendra Majhi vrs State of Odisha and others). Hon'ble High Court vide their judgment dated 16.01.2026 passed in CRLMC No. 1017 of 2024 and another case have disposed of the CRLMC applications and has quashed the entire criminal proceeding pertaining to Sri Majhi.

As such, Sri Rajendra Majhi, who was earlier posted to Steel and Mines Department upon his appointment as Assistant Section Officer, is hereby posted as such in Home Department against the existing vacancy with effect from dated 13.02.2024 (F.N.).

The benefits in the post of ASO from dated 13.02.2024 to the date he actually joins in the present post in Home Department shall be decided on the final outcome of the W.P.(C) No. 11904 of 2024 pending before the Hon'ble High Court.

Home Department Order No.5446/OSS, dated 08.02.2024 stands modified accordingly.

The Home Department letter no. 7131 OSS Dated 24.02.2026 has sought clarification regarding acceptance of joining report submitted by Rajendra Majhi in the post of Assistant Section Officer. The file reveals Sri Majhi on being selected by Odisha Public Service Commission submitted his joining report on 08.02.2024 the same was not accepted by the Administrative Department on the ground that a criminal case is pending against him allegedly participating in the demonstration in front of the Board of Secondary Education.

Challenging the propriety of the Criminal Proceeding in S.T. Case No. 39 of 2024 corresponding to G.R. Case No. 372 of 2018 arising out of Mangalabag P.S. Case No. 44 of 2018, two criminal miscellaneous cases under section 482 Cr.P.C. were filed by the accused persons including Rajendra Majhi in Criminal Misc. Case No. 1017/24.

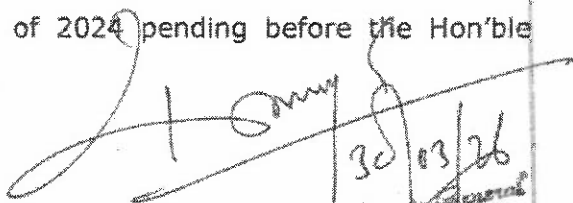
The Hon'ble High Court by a common judgment and order passed in 2832 of 2024 and CrI. Misc. Case No. 1017 of 2024 on appreciation of the material pertaining to the implication of the petitioner therein were clearly of the view that Rajendra Majhi and some other accused persons did not figure in the First Information Report. So therefore on being prime facie satisfied, applying the well settled proposition of

law involved in the case of State of Hariyan vrs Bhajanlal by a common comprehensive judgment dated 21.1.2026 was pleased to quash the criminal proceeding of the petitioner.

Therefore, in the eye of law Rajendra Majhi does not suffer from any disability to get to Government Service. A/D may accordingly accepts the joining report so submitted by Sri Majhi on 08.02.24. So far as the benefit from w.e.f. 08.02.2024 till he joins in the present post is concerned the same may depend upon the final out come of the writ petition bearing WP(C) No. 11904 of 2024 pending before the Hon'ble High Court.
