Odisha Staff Selection Commission vide their Notification No. 22/OSSC, dated 02.01.2026 has recommended the name of an additional candidate, namely Sri Sabyasachi Mohanty, pursuant to the Advertisement No. 2650 dated 20.05.2015, for his appointment in the post of Junior Data Entry Operator in Odisha Secretariat under Home Department, Government of Odisha (Group-C).
