In compliance to the order Dt.02.04.2025 of the Hon'ble High Court Passed in W.P (C) No-6925 of 2024, Sri Ashish Kumar Dash, E.O, DMET, Odisha was notionally promoted to the rank of Admn. Officer w.e.f. Dt.11.07.2022, i.e. the date of promotion of his immediate junior Sri Jeebanananda Panda with financial benefits from the date of his actual joining in the promotional post vide this Department Notification No.27977 Dt.04.07.2025. Subsequently, in compliance to the order Dt.27.02.2026 of the Hon'ble High Court passed in CONTC No-21 of 2026 arising out of W.P (C) No-6925 of 2024 and in partial modification of this Department Notification No.27977 Dt.04.07.2025, he was allowed financial benefits in the promotional post of Admn. Officer w.e.f. Dt.11.07.2022.

Consequent upon revision of the Gradation List of the Establishment Officers of Heads of Department Common Cadre published on Dt.23.11.2021 in pursuance of the common judgment Dt. 28.03.2025 of the Hon'ble High Court passed in W.P.(C) No.31396 of 2024 and a batch of cases and publication of the revised Final Gradation List of Establishment Officers on 18.04.2026, a review meeting of the DPC was held on 22.05.2026 for consideration of promotion of Establishment Officers to the rank of Administrative Officer. On the basis of recommendation of the review DPC held on 22.05.2026, Shri Ashish Kumar Dash, Administrative Officer, Directorate of Combined Health Services, Odisha, Bhubaneswar is hereby promoted to the said rank notionally w.e.f. Dt.29.01.2022 i.e. the date of his junior Shyamal Kumar Roy promoted vide Home Deptt. Notification No.2530, Dt.29.01.2022 with financial benefits w.e.f. Dt.11.07.2022 as per Home Department Office Order No.11269/CC Dt.31.03.2026, on ad-hoc basis for a period of one year or till receipt of recommendation of Odisha Public Service Commission or till the date of his retirement, whichever is earlier subject to outcome of related cases, if any. This Department Notification No.27977 Dt.04.07.2025 and Office Order No.11269/CC Dt.31.03.2026 are modified accordingly.

On such promotion, he is posted as Administrative Officer in the Directorate of Agrilculture & Food Production, Odisha, Bhubaneswar.
