NOTIFICATION

Bhubaneswar, the dated 21.05.2026

F.No. HOME-CPM-MISC-0101-2026/- 17652/CP&M, In pursuance of the D.O. letter No.25015/01/2025-LC (Pt.II) dated 13.11.2025 of the Ministry of Home Affairs, Government of India and in view of the emphasis laid on the urgent need to strengthen the mechanism for bringing back fugitives wanted by Indian Law Enforcement Agencies, the Government, after careful consideration, have been pleased to order establishment of a specialized “**Extradition Cell**” in the CID, Crime Branch, Odisha, Cuttack.

The Extradition Cell shall function under the direct supervision of the **Inspector General of Police-cum-Interpol Liaison Officer (ILO), CID, Crime Branch, Odisha, Cuttack**, to ensure effective coordination with national and international law enforcement agencies. This Extradition Cell will also have the following dedicated officers and experts:

1. Superintendent of Police, CID, Crime Branch – Member
2. Four Deputy Superintendents of Police (Dy.SsP), one each from the following wings:
 - i. Cyber Cell
 - ii. Crimes Against Women & Children (CAW&C), Bhubaneswar
 - iii. Economic Offences Wing, Bhubaneswar
 - iv. Special Task Force, Bhubaneswar
3. Section Officer (Prosecution), CID, Crime Branch – Member Convener

The Cell shall be responsible for:

- i. Preparation, scrutiny and vetting of all extradition and provisional arrest requests at the State level;
- ii. Ensuring completeness of legal documentation as per treaty requirements and international norms;
- iii. Furnishing clarifications to foreign judicial authorities;
- iv. Liaison with MHA, MEA, INTERPOL through the CBI, New Delhi;
- v. Preparing counters to defence documents during international hearings;
- vi. Assisting Investigating Officers in drafting replies, clarifications and counter-affidavits during extradition proceedings abroad;

The CID, Crime Branch, Odisha, being the nodal agency for INTERPOL-related matters in the State, shall ensure that the Extradition Cell functions as a dedicated unit for all extradition-related processes in coordination with the concerned authorities.

This Notification shall come into force with immediate effect.

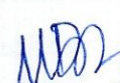
