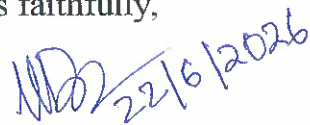

The objections received beyond the stipulated date in this regard shall not be entertained.

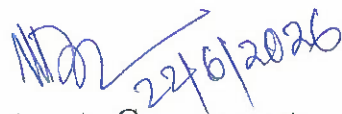
